KNOW ALL MEN BY THESE PRESENTS:

That we, STEWART-BARRY ROOFING & INSULATION Co. INC.  
as Principal, and Selective Insurance Company of America, a corporation of the State of New Jersey, as Surety, are held and firmly bound unto the BOARD of Commissioners of the County & Towns in LAKE County, INDIANA, as Obligees in the penal sum of FIVE THOUSAND DOLLARS & 00/100 (Not valid for more than \$25,000).

This bond shall remain in force for a one year period beginning on the 2<sup>ND</sup> day of JANUARY, 2018 and ending on the 2<sup>ND</sup> day of JANUARY, 2019.

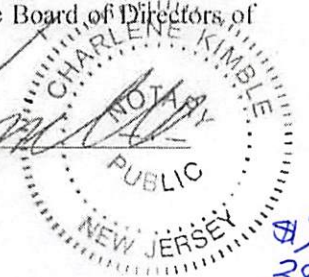
