Minor (Child) Power of Attorney Form

This power of attorney document for a minor child was created and signed in the County of Lake, State of Indiana with the parties to agree as follows:

The Minor. This power of attorney document is intended for the rights to make parental or guardian decisions on behalf of the Minor named Kane Micah Lanehart-Weston born on October 21st 2017 (Hereinafter known as the 'Minor').

Principal. The mother:

Powers. The Principal delegates the Attorney-in-Fact to: Choose a school, view educational records, and to approve of any after-school activities. Provide food, clothing, shelter, and everyday care for the child's physical and emotional well-being. View medical records and make any type of health care decision. Travel anywhere in the USA.

Are there any other powers the Principal would like to grant? Yes. I also grant permission for Hebrew religious practices, International travel, Talent & Model agency, Music & Theater school use of photos, photography, and videos via any and all social media, and to speak with Court Services, Indiana Department of Child Services, case managers, any and all encounters in reference to the minor.

Limitations. The Principal shall not have any restrictions.

Commencement Date. This power of attorney document shall commence On December 21st 2017.

Termination Date. This document shall terminate in not more than 6 months on November 30th 2018.

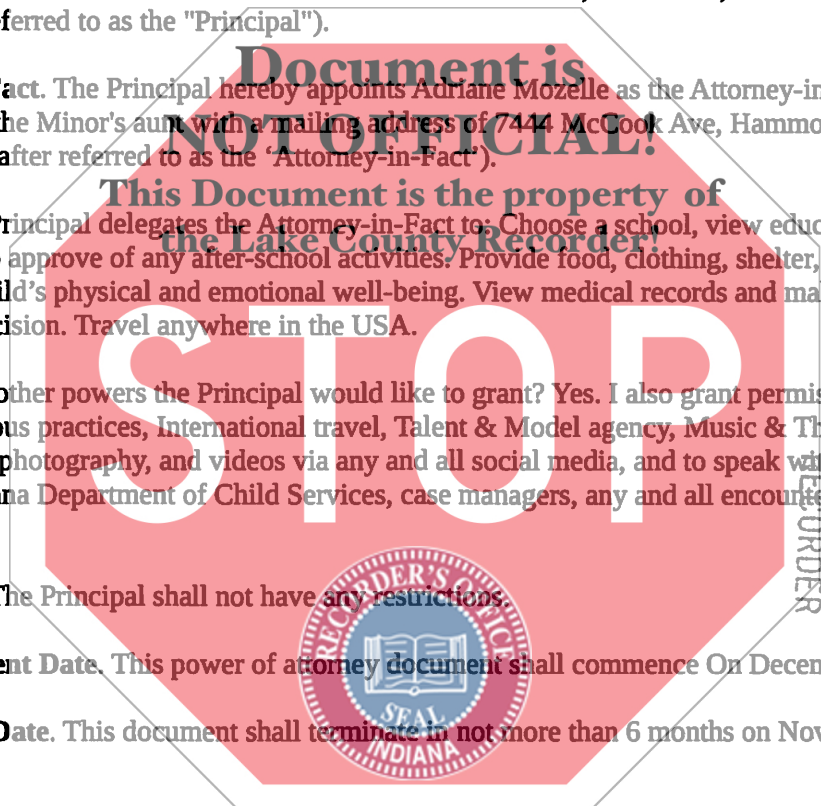
In addition, this minor power of attorney shall terminate at anytime by the Principal completing a revocation or creating a new minor power of attorney form.
