### QUITCLAIM DEED

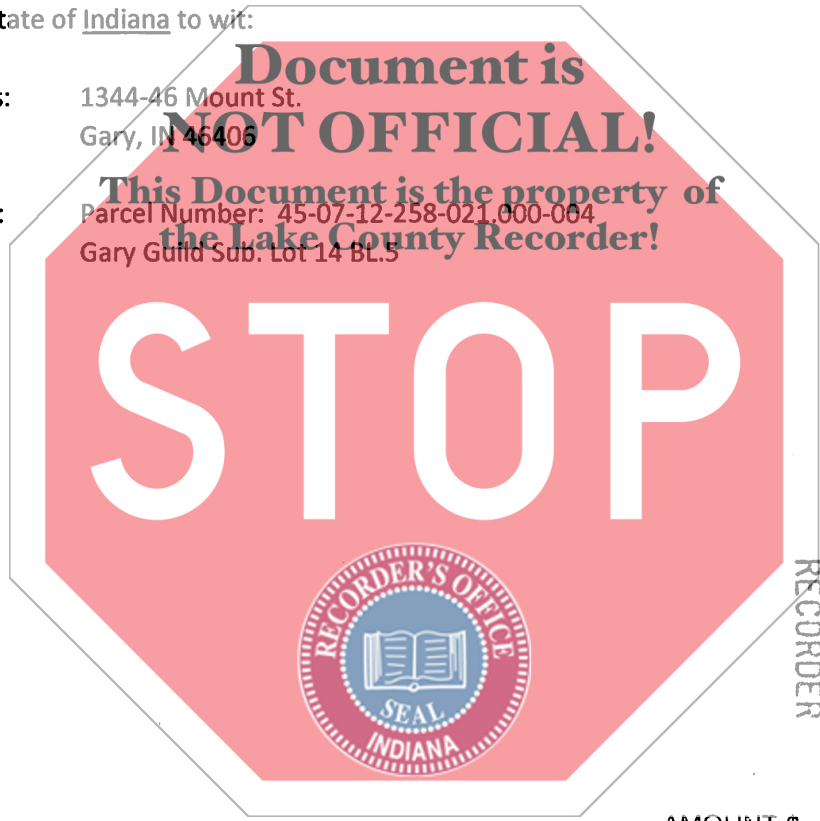

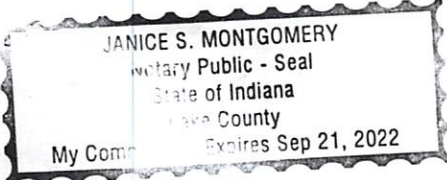
