**MEMORANDUM OF RESTATEMENT OF THE SHULOCK LIVING TRUST DATED MARCH 01, 2017**

Part of Lot 6 in Springvale Farms Court I, in the Town of Schererville, as per plat thereof, recorded in Plat Book 58, page 48, and corrected by Certificate of Correction recorded March 29, 1985 as Document No. 797367, in the Office of the Recorder of Lake County, Indiana, described as follows: Commencing at the Northwest corner of said Lot 6; thence East along the Northerly line of said Lot 6, 89.11 feet to the Northeasterly line of said Lot 6; thence Southeast along said Northeasterly line, 13.20 feet to the point of beginning; thence continuing Southeast along said Northeasterly line, 32.60 feet; thence South 37 degrees 19 minutes 47 seconds West, 119.86 feet to the Southwesterly line of said Lot 6; thence Northwest along said Southwesterly line, 32.60 feet; thence North 37 degrees 19 minutes 47 seconds East, 120.39 feet to the place of beginning, commonly known as Unit 6-3, 1864 Plum Court.

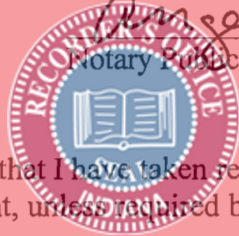


