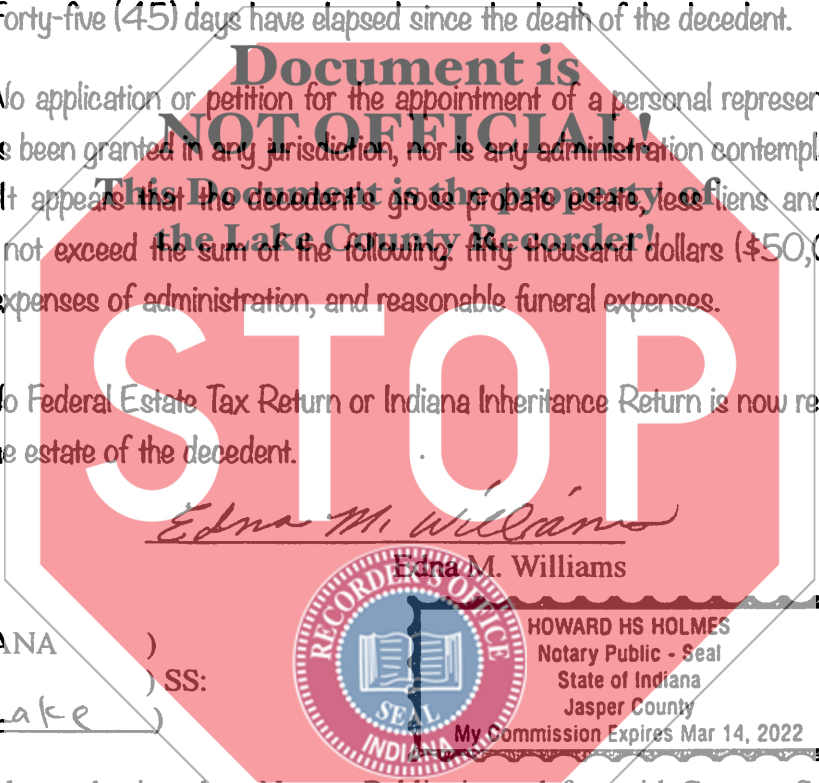

11. At the time of her death, Bonnie. Harris had no children nor heirs.

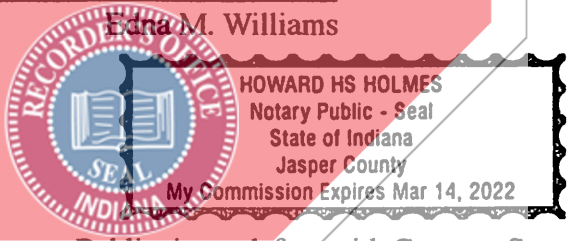
