KNOW ALL MEN BY THESE PRESENTS:

That we, **Concrete By Wagner, Inc.**
as Principal, and Selective Insurance Company of America, a corporation of the State of New Jersey, as Surety, are held and firmly bound unto the **The Board Of Commissioners Of The County Of Lake,** as Obligees in the penal sum of **State Of Indiana and any City & Town in Lake County, IN** Five Thousand Dollars (00/100) (Not valid for more than (\$25,000):

lawful money of the United States, to be paid to the said Obligees, for which payment well and truly to be made we bind ourselves and our legal representative, jointly and severally.

The condition of this obligation is such that whereas Principal desires to obtain a license or permit to carry on business as a **Concrete Construction**

This bond shall remain in force for a one-year period beginning on the 24th day April, 2019 and ending on the 24th day of April, 2020.

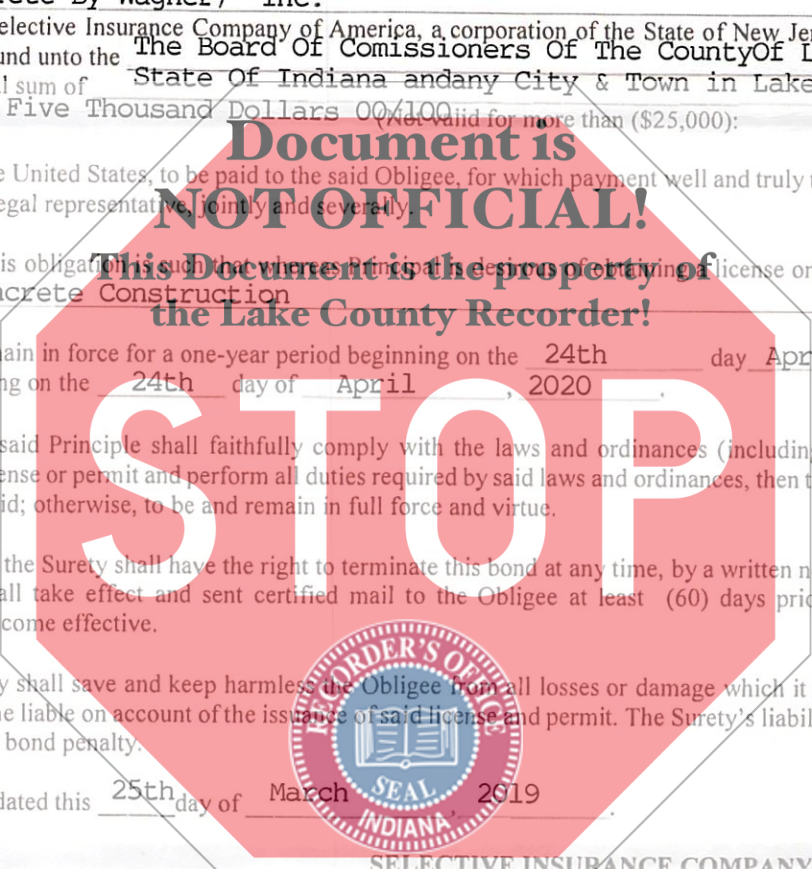
