hereon.

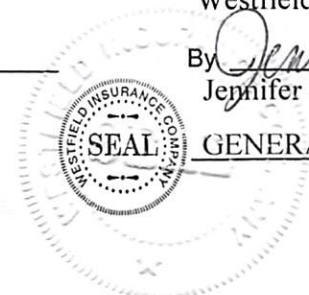
