FIRST AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR DANCING WATERS TOWNHOMES

This First Amendment is made this day by **DANCING WATERS TOWNHOMES LLC**, an Indiana limited liability company (hereinafter referred to as the "Declarant"), and **DANCING WATERS TOWNHOME OWNERS ASSOCIATION**, INC. and Indiana nonprofit corporation (the "Association").

WHEREAS, the Declarant did cause the Declaration Of Covenants, Conditions, Restrictions And Easements For Dancing Waters Townhomes to be recorded on June 23, 2016, as Document No. 2016 038871, in the Office of the Recorder of Lake County, Indiana (herein together the "Declaration"); and

WHEREAS, Declarant desires to amend the Declaration to correct scrivener's errors as provided in Article XIII. Section 1.d.(1) of the Declaration; and

WHEREAS, the Association is the fee simple owner of the Common Area, as defined in the Declaration.

NOW, THEREFORE, the Declarant and the Association declare that the Declaration be, and the same is hereby, amended pursuant to Article XIII. Section 1.d.(1) of the Declaration, as follows:

1. Article XI, Section 6 of the Declaration is hereby amended and restated in its entirety as follows:

"<u>Section 6</u>. <u>Animals</u>. An owner may not keep, raise or breed any animals, reptiles, livestock or poultry in or on a Residential Unit, provided, however, that two (2) pets (dogs or cats only) shall be allowed to be kept in or on a Residential Unit, subject to any rules and regulations of the Association.
