KNOW ALL MEN BY THESE PRESENTS:

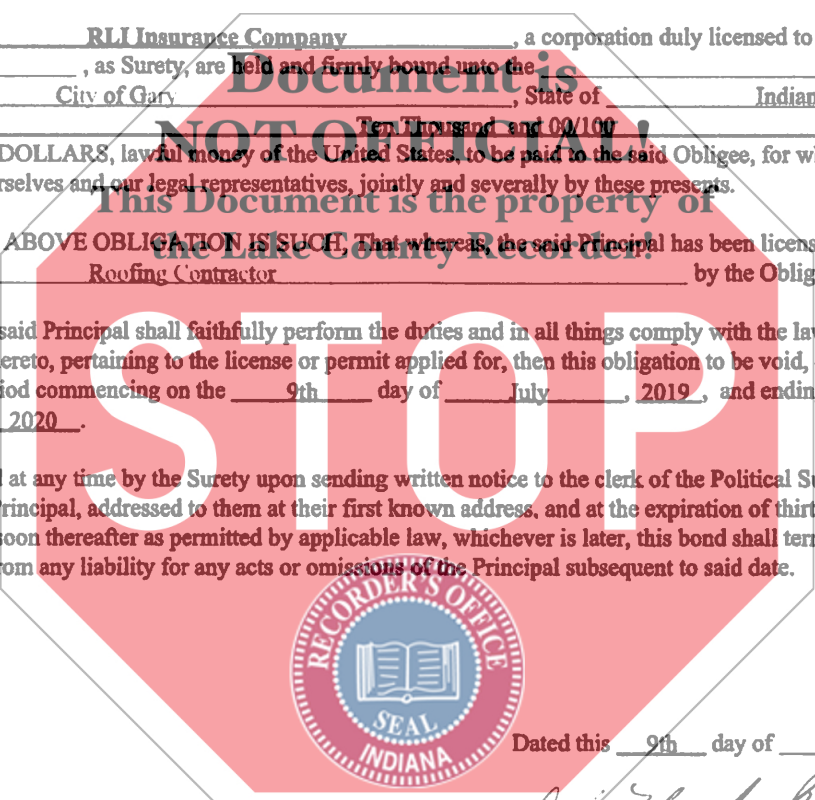
That we, MRB Roofing, Inc.
