**REAL ESTATE MORTGAGE**



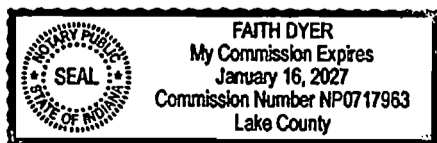
