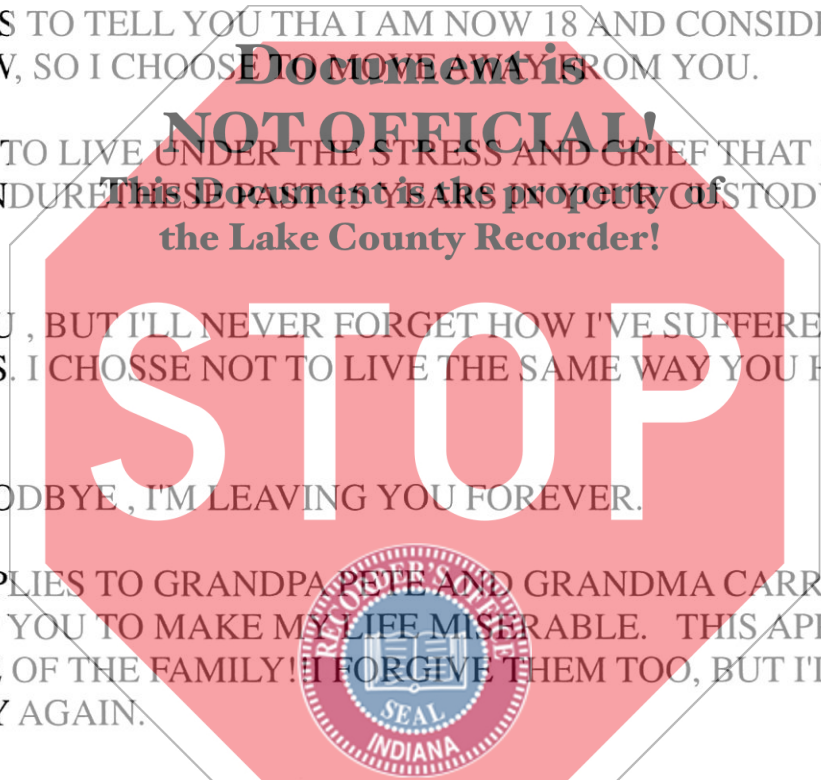
I'M NOT KIDDING AND I AM NOT KIDNAPPED!! THIS IS MY CHOICE!!

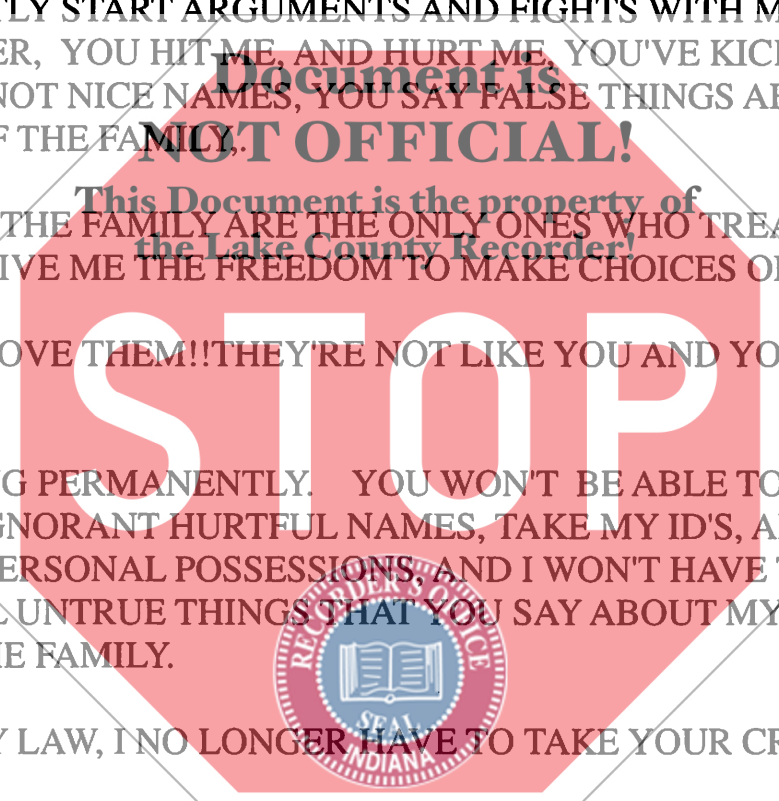
I AM DONE!! BY LAW, I NO LONGER HAVE TO TAKE YOUR CRAP!!

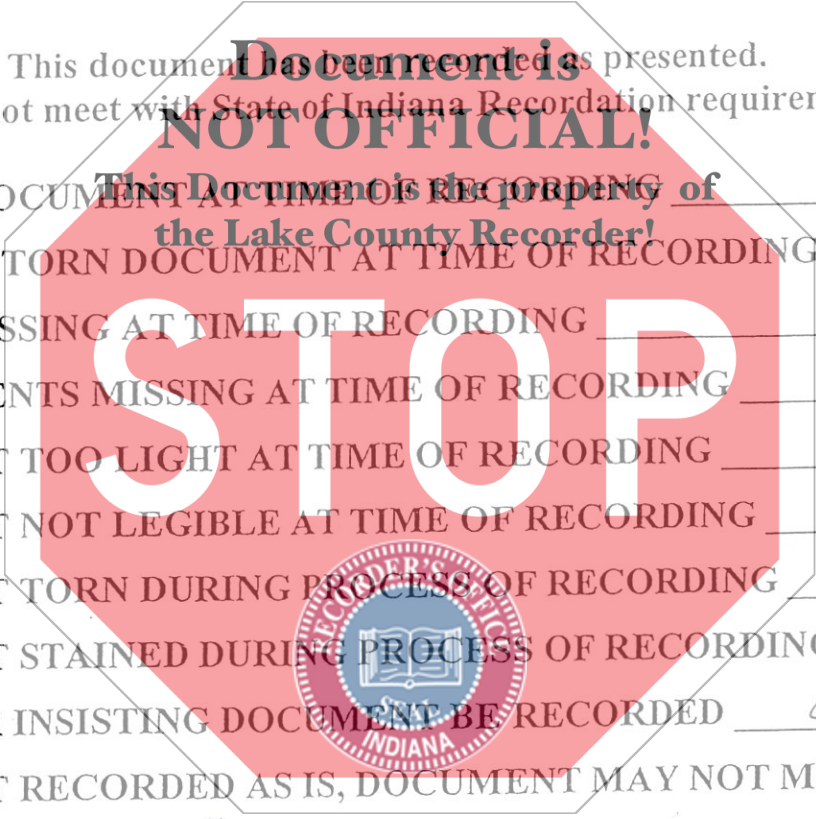
