So I am going to leave and be a man. I want you to see that I can make you proud and prove the lessons you have taught me in the short time we were together are not forgotten. I'm glad you tell me to get washed up when I get there and that I have my own room, Dad made me sleep with him every night, even though there were two beds. 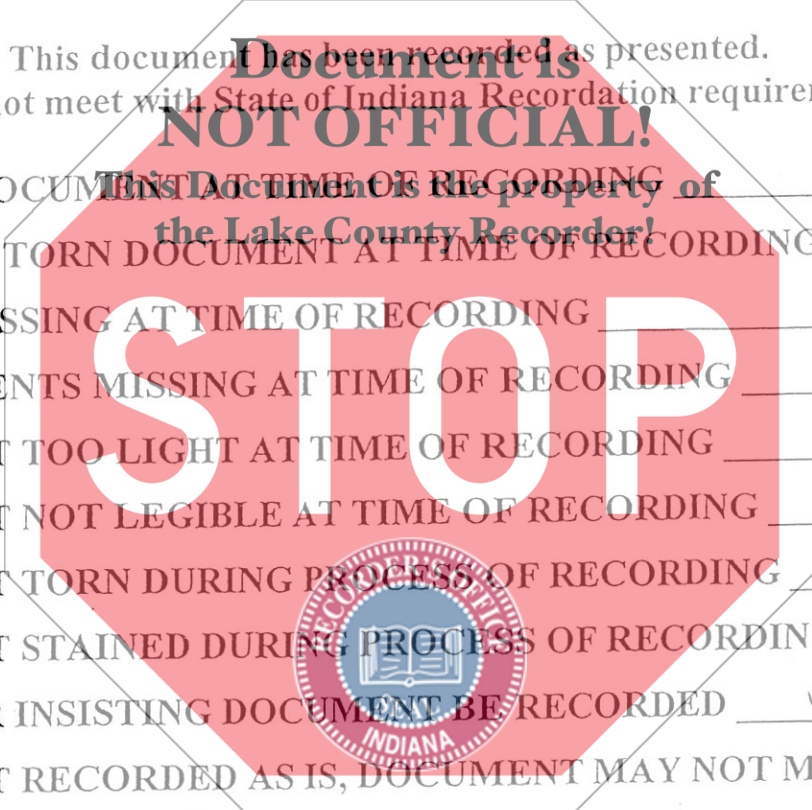
