(b) OWNER agrees to maintain the property as an owner-occupied residential property for minimum of TEN years from the date of the completion of the project (the "Affordability Period"). In the event that the OWNER shall sell transfer, or refinance the property during the Affordability Period, then the Department of Community Development shall be entitled to the return of funds paid for repair of the property, on a pro rata basis. The Department shall have a lien on the property in the contract amount.
