The Mortgagor represents there are no unpaid liens outstanding against the mortgaged premises except unpaid real estate taxes for the year 2019 payable in 2020 and the Mortgagor shall not permit any lien to attach to and remain on the Mortgaged Premises This Document is the property of for more than 45 days after receiving notice thereof from the Mortgagee.
- 3. Property Not Intended for Occupancy by Mortgagor. The Mortgagor represents that the mortgaged premises are not intended for occupancy by the Mortgagor or members of his family.
