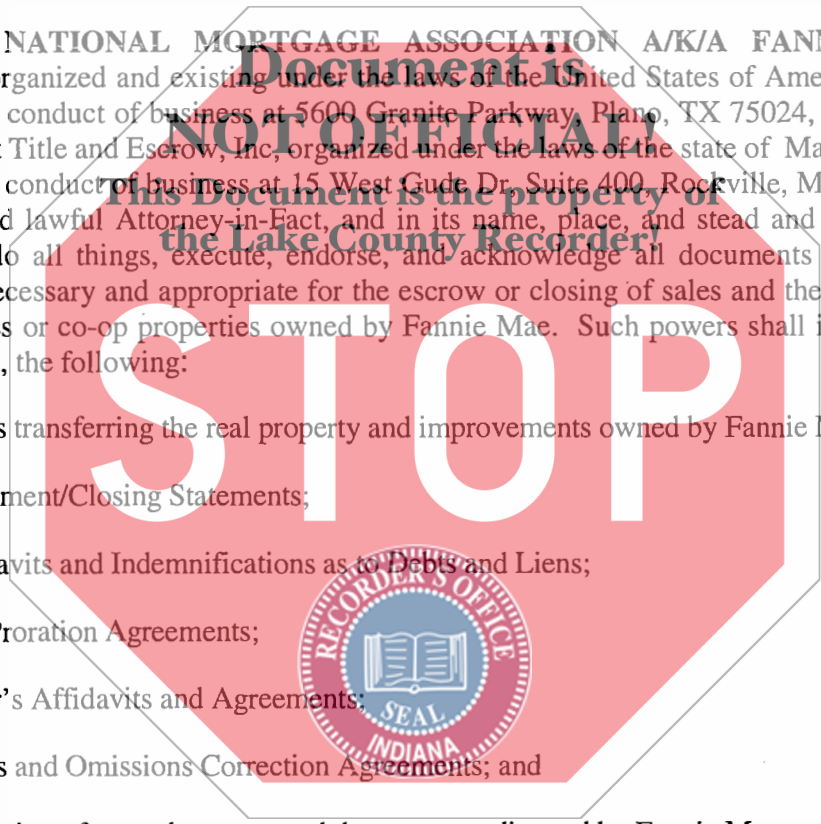

LIMITED POWER OF ATTORNEY TO EXECUTE DOCUMENTS

Such powers shall include, but are not limited to, the following:

5. Seller's Affidavits and Agreements;
