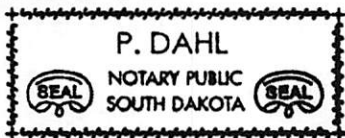

Term of bond: August 3rd, 2020, to August 3rd, 2021.



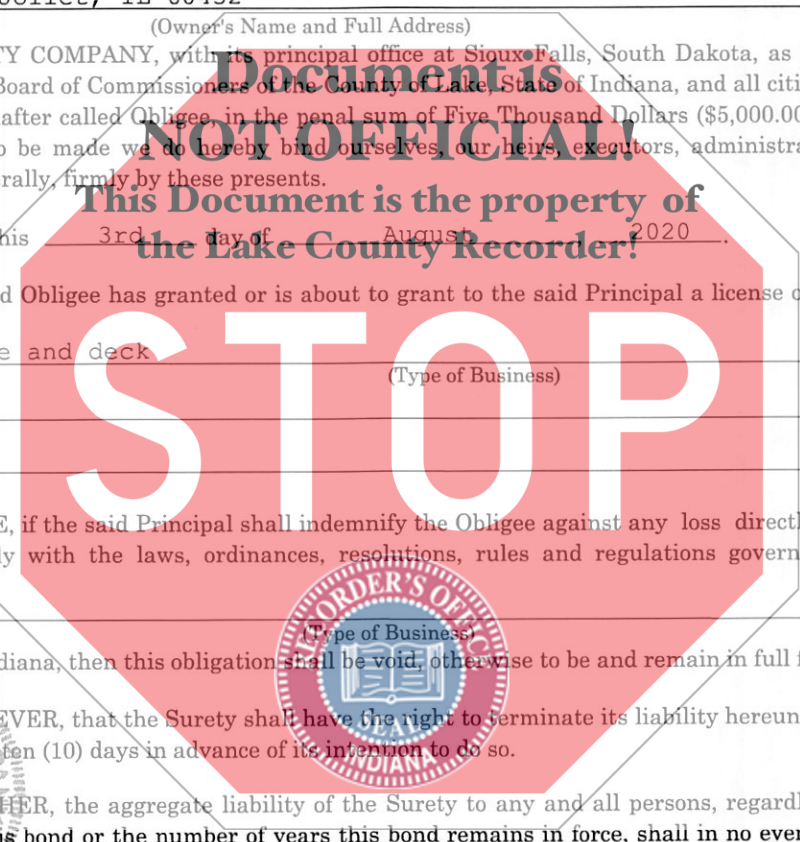

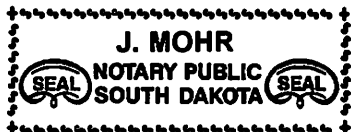
