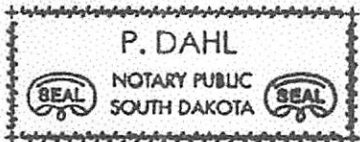
WHEREAS, the said Obligee has granted or is about to grant to the said Principal a license or permit to engage in the business of Carpentry Contractor County of Lake

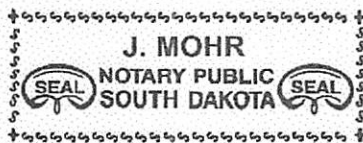
