**AFFIDAVIT FOR TRANSFER OF PERSONAL PROPERTY**

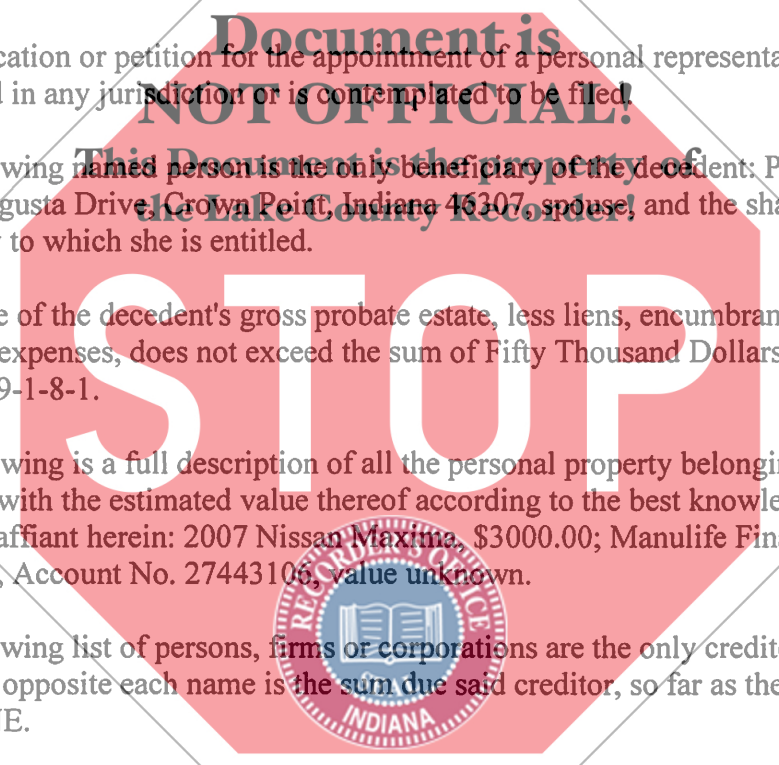
