This Security Instrument will not secure any other debt if Lender fails, with respect to that other debt, to fulfill any necessary requirements or to conform to any limitations of Regulation Z and X that are required for loans secured by the Property.

4. Mortgage Covenants. Mortgagor agrees that the covenants in this section are material obligations under the Secured Debt and this Security Instrument. Removal of Improvements. Mortgagor shall not demolish or remove any improvements from the Property without Lender's prior written consent. Compliance with Governmental Requirements.
