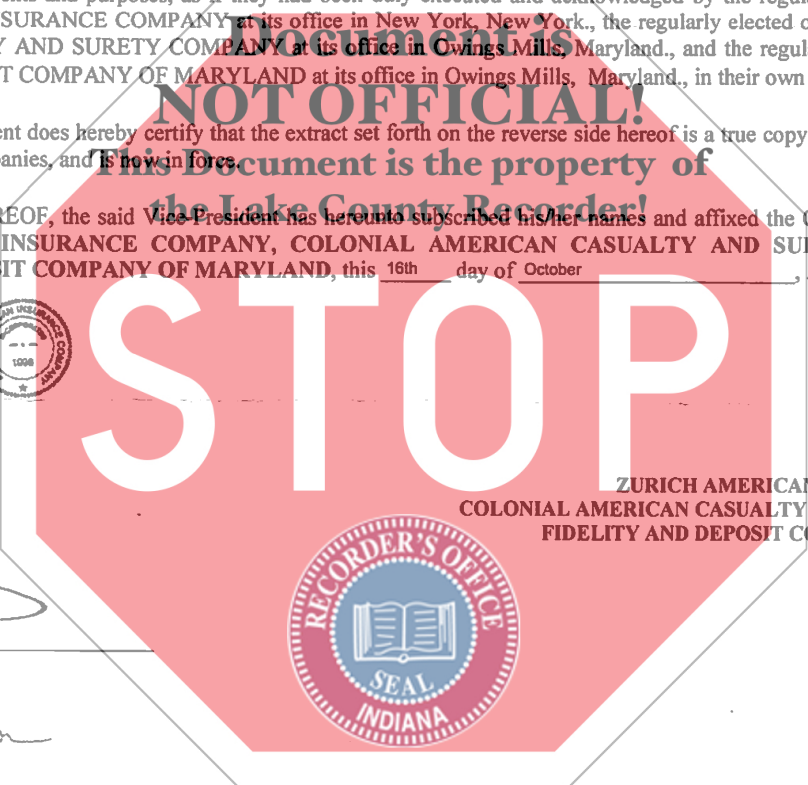

"Article V, Section 8, Attorneys-in-Fact. 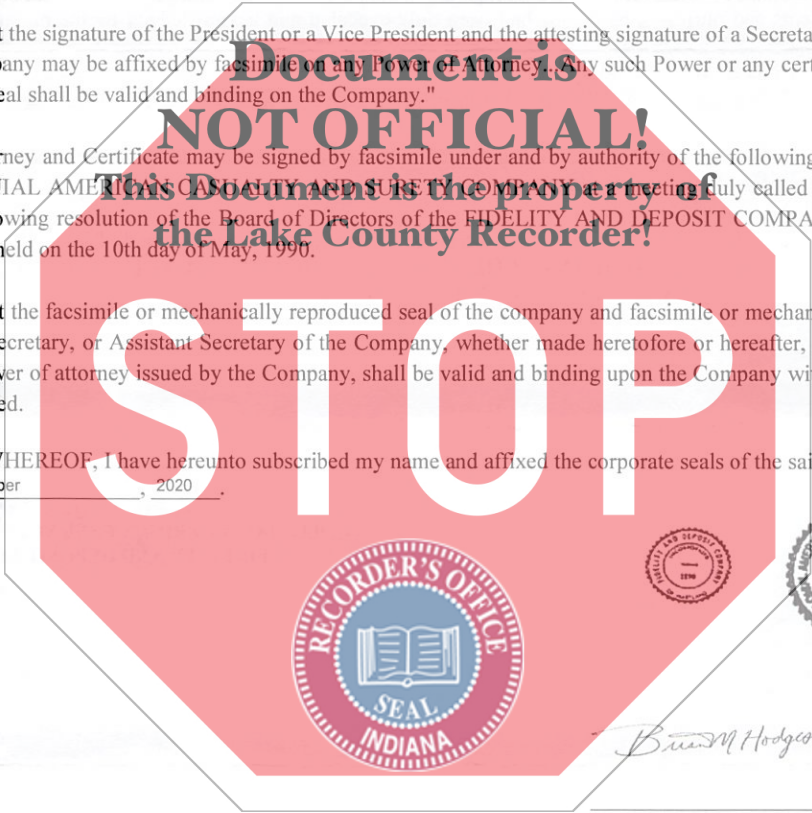
