

Comes now Megan Flores and states:


- 1 I am the Controller for the City of Hammond and am charged with collecting fees and penalties owed to the City of Hammond

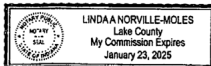
