REMOVE AND REPLACE THE EXISTING DRIVEWAY MEASURING APPROX. 10'X101' WITH A 16'X7' AREA THAT WIDENS OUT NEAR THE GARAGE. REMOVE AND REPLACE THE FRONT SERVICE SIDEWALK MEASURING APPROX. 3'X24' WITH A 7'X5' PAD. DIG OUT AND POUR A NEW SECTION OF DRIVEWAY FOR AN ADDITIONAL CAR MEASURING APPROX. 30'X8'.
