#### POWER OF ATTORNEY

- 3. To endorse any checks or other instruments received by SLS and made payable to Trustee.
- 4. To pursue any deficiency, debt of other obligation, secured or unsecured, including but not limited to those arising from foreclosure or other sale, promissory foce or check. This power also authorizes SLS to collect, negotiate or otherwise settle any deficiency claim, including united and attorney's fees.
