16th day of September, 2022

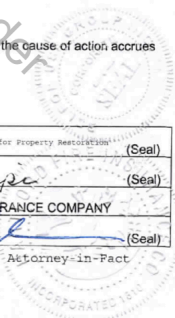
No cause of action shall lie against the surety unless commenced within two years from the date the cause of action accrues
