LIMITED POWER OF ATTORNEY

("SPS"), and its name, aforesaid Attorney-In-Fact, by and through any officer appointed by the Board of Directors of Select Portfolio Servicing, Inc., to execute and acknowledge in writing or by facsimile stamp all documents customarily and reasonably necessary and appropriate for the tasks described in the items (1) through (4) below; provided, however, that the documents described below may only be executed and delivered by such Attorneys-In-Fact if such documents are required or permitted under the terms of the Pooling and Servicing Agreement, dated as of November 1, 2006, among Credit Suisse First Boston Mortgage Securities Corp., as Depositor, DLJ Mortgage Capital, Inc., as Seller, Wells Fargo Bank, N.A., as Servicer, Select Portfolio Servicing, Inc., as Servicer and Modification Oversight Agent, Clayton Capital Income Services, Inc., as Credit Risk Manager and U.S. Bank National Association, as Trustee, relating to Home Equity Asset Trust 2006-8, Home Equity Pass-Through Certificates, Series 2006-8, and no power is granted hereunder to take any action that would be adverse to the interests of the Trustee of the Holder. 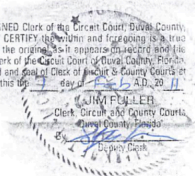
