LIMITED POWER OF ATTORNEY

The authorization for assignment is strictly limited to Assignment of Mortgage of Mortgage Loans and Associated PPC Loans to Beltway Capital, LLC, not in its individual capacity but solely as Administrator of Western Run Capital Management Trust. Any assignment to any other entity other than Beltway Capital, LLC, not in its individual capacity but solely as Administrator of Western Run Capital Management Trust shall be void.
- To execute, on behalf of HUD, a release of lien or equivalent for each HUD-Held Second Mortgage provided in <u>EXHIBIT A</u>, where Beltway Capital, LLC, not in its individual capacity but solely as Administrator of Western Run Capital Management Trust bears

full responsibility for ensuring such assignments are in a form that complies with applicable local, state and federal law.

This instrument is to be construed and interpreted as a limited power of attorney and does not empower or authorize the said attorney-in-fact to do any act or execute any document on behalf of HUD not specifically described herein.

The rights, powers, and authority of the attorney-in-fact granted in this instrument shall commence and be in full force and effect on the date hereof and such rights, powers and authority shall remain in full force and effect until 11:59 p.m. Eastern Time, on **December 31**, 2022.
