2. Application of Payments or Proceeds. Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note: (b) principal due under the Note: (b) amounts due under shall be applied to each Periodic Payment in the order in which it became due. Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. If the insurance or condemnation proceeds are not sufficient to repair or restore the Property, Borrower is not relieved of Borrower's obligation for the completion of such repair or restore the Property.




