AGREEMENT FOR TERMINATION AND RELEASE OF BUCKEYE PIPELINE RELOCATION RECAPTURE AGREEMENT

THIS AGREEMENT is made this _____ day of August, 2022, by and between the City of Crown Point, Lake County, Indiana, a municipal corporation, by and through its Board of Public Works ("City"), and I65 Properties, LLC, an Indiana limited liability company ("Developer").

WHEREAS, the City and Developer are parties to a Buckeye Pipeline Relocation Recapture Agreement June 11, 2014 ("2014 Agreement"), recorded as Document No. 2014-034409 on June 16, 2014 in the Office of the Recorder of Lake County, Indiana, applicable to the following real estate located in the Crown East Development, Crown Point, Indiana ("Real Estate"):

Lot 1: 45-16-10-128-006.000-042 Lot 2: 45-16-10-128-005.000-042

Lot 3: 45-16-10-128-004.000-042

Lot 4: 45-16-10-128-001.000-042

WHEREAS, as a result of agreements between the parties subsequent to the execution of the 2014 Agreement, the 2014 Agreement is unnecessary to accomplish the purposes and intents of that 2014 Agreement and the parties therefore desire to terminate the 2014 Agreement and be mutually released from further performance of the terms and conditions of the 2014 Agreement.

NOW THEREFORE, for valuable consideration and the mutual releases, undertakings, terms and conditions contained in this Agreement, the parties agree as follows:

- City agrees to terminate the 2014 Agreement in that the Developer has already relocated the pipeline and desires to terminate any obligation of the City from making payments to the Developer pursuant to the terms of the 2014 Agreement.
- Developer agrees to terminate the 2014 Agreement and releases City from all further obligations to make payments to the Developer according to the 2014 Agreement and releases the City from all obligations to the Developer by reason of the 2014 Agreement.
