TO THE CITY OF CROWN POINT
(Hidden Lakes – Phase 1)

WHEREAS, the Common Council has considered and examined the real estate described below and its future in relation to the City; and,

WHEREAS, the real estate is contiguous to and is bounded by the City of Crown Point on at least one-eighth (1/8) of the aggregate external boundaries of said territory; and

WHEREAS, one hundred percent (100%) of the owners of real estate have signed the petition for Annexation heretofore filed; and,

WHEREAS, the Common Council, preceding adoption of this Ordinance, has approved the recommendation of the City's financial consultant regarding a written fiscal plan for the real estate pursuant to IC §36-4-3-3.1(d); and,

WHEREAS, the Common Council has conducted a public hearing regarding the subject of the proposed annexation; and,

WHEREAS, it is desirable that the City of Crown Point control the use of the subject real estate and, that in order to promote the orderly growth of the same, the real estate be annexed with the "R-1A" zoning district classification; and,

WHEREAS, essential municipal services are reasonably available to the subject real estate in conformance with the terms of said fiscal plan.

NOW, THEREFORE, BE IT HERBY ORDAINED by the Common Council of the City of Crown Point as follows:

1. That the real estate described below be and it is hereby annexed to the City of Crown Point, to-wit:

5. The said annexation be effective from and after passage, adoption, and publication of this Ordinance and after passage of statutory periods of time for approval.
