DURABLE POWER OF ATTORNEY

III. LIABILITY AND INDEMNITY. My attorneys-in-fact shall only be liable for actions taken in bad faith; provided, however, my attorneys-in-fact shall be liable for the negligent exercise of the powers described herein if the exercise of such power involves self-dealing. I hereby ratify and confirm all that my attorneys-in-fact shall do by virtue hereof. Further, I agree to indemnify and hold harmless any person who, in good faith, acts under this Power of Attorney or transacts business with my attorneys-in-fact in reliance upon this Power, without actual knowledge of its revocation.

EFFECTIVE DATE, INCAPACITY, AND LIMITATIONS.

- This Power of Attorney shall be effective upon the A. date of execution hereof.
- This Power of Attorney is not terminated by my В. incapacity.
- REVOCATION. I hereby reserve the right to revoke this Power of Attorney at any time. It is my intention that this Power of Attorney is intended to revoke all powers of attorney previously executed by me.
