Mortgagor (1) releases and waives any future claims against Lender for indemnity or contribution in the event Mortgagor becomes liable for cleanup or other costs under any such laws, and (2) agrees to indemnify and hold harmless Lender gainst claims, losses, liabilities, damages, penalties, and expenses which Lender may directly or indirectly, sustain resulting from a breach of this section or as a consequence of any use, generation, manufacture, storage, disposal, release or threatened release occurring prior to Mortgagor ownership or interest in the Property, whether or not the same was or should have been known to Mortgagor. - 16. Reinstatement of Security Interest. 
