KNOW ALL MEN BY THESE PRESENTS:

THAT WE, TROCH-MCNEIL PAVING CO., INC., as Principal, and Travelers Casualty and Surety Company of America, a corporation duly incorporated under the laws of the State of Connecticut and authorized to do business in the state of INDIANA, as Surety, are held and firmly bound unto The Board of Commissioners of the County of Lake, State of Indiana (the "Board"), and all cities, towns and municipalities in Lake County, Indiana, as Obligees, in the penal sum of Five Thousand (\$5,000.00) Dollars, for the payment of which we hereby bind ourselves, our heirs, executors and administrators, jointly and severally, firmly by these presents.


This bond is for a definite term beginning June 28, 2023, and ending June 28, 2024, and may be continued at the option of the Surety by Continuation Certificate.
