LIMITED POWER OF ATTORNEY

Nationstar Mortgage LLC ("Nationstar"), with an address of 8950 Cypress Waters Blvd. Coppell, TX 75019, along with its successors and assigns, as the Servicer and Nominee to certain mortgage loans or real estate owned property (the "Loans") that constitute the Trust Estate under (i) that certain Assignment Agreement by and between Bayview Koitere Fund Trust 2017-RT4 (the "RT4 Seller") and Citigroup Global Markets Realty Corp. ("Purchaser") dated November 25, 2022 (the "RT4 Agreement"), (ii) that certain Assignment Agreement by and between Bayview Opportunity Master Fund IVa Trust 2017-RT5 (the "RT5 Seller") and Purchaser dated November 25, 2022 (the "RT5 Agreement") and (iii) that certain Assignment Agreement by and between Bayview Opportunity Master Fund IVb Trust 2017-RT6 (the "RT6 Seller") and Purchaser dated November 25, 2022 (the "RT6 Agreement"), and together with the RT5 Agreement and the RT4 Agreement, the "Agreements" and each, an "Agreement") hereby appoints Meridian Asset Services, LLC a Delaware limited liability company, ("Meridian") with an office located at 3201 34th Street South, Ste B310, St. Petersburg FL 33711, as its true and lawful attorney-infact to act in the name, place and stead of Nationstar with respect to each Loan sold to Purchaser pursuant to each Agreement for the following, and only the following, purposes:

- 1. To execute, acknowledge, seal and deliver deed of trust/mortgage note endorsements, assignments of deed of trust/mortgage and other recorded documents, satisfactions/ releases/reconveyances of deed of trust/mortgage, tax authority notifications and declaration, deeds, bills of sale, and other instruments of sale, conveyance, and transfer, appropriately completed, with all ordinary or necessary endorsements, acknowledgments, affidavits, and supporting documents as may be necessary or appropriate to effect its execution, delivery, conveyance, recordation of filing.
- 2. To execute and deliver affidavits of debt, substitutions of trustee, substitutions of counsel, non-military affidavits, notices of rescission, forcelosure deeds, transfer tax affidavit, affidavits of merit, verification of complaint, notices to quit, bankruptey declarations for the purpose of filing motions to lift stays and other documents or notice filings on behalf of Prior Servicer in connection with forcelosure, bankruptey and eviction actions.
- Execute or file quitclaim deeds or, only when necessary and appropriate, special warranty deeds or other deeds causing the transfer of title to Meridian or third party, in respect of property acquired though a foreclosure or deed-in-lieu of foreclosure ("REO Property").
- To endorse and/or assign checks or negotiable instruments received by Meridian as a Mortgage Loan Payment.

Nationstar intends that this Limited Power of Attorney be coupled with an interest and irrevocable.

Nationstar further grants to its attorney-in-fact full authority to act in any manner both proper and necessary to exercise the foregoing powers, and ratifies every act that Meridian may lawfully perform in exercising those powers by virtue hereof.

Nationstar further grants to Meridian the limited power of substitution and revocation of another party for the purpose and only for the purpose of endorsing or assigning notes or security instruments in Nationstar's name, and hereby ratifies and confirms all that the attorney-in-fact, or its substitute or substitutes, shall lawfully do or cause to be done by authority of this power of attorney and the rights and powers granted hereby.

Meridian shall indemnify, defend and hold harmless Nationstar and its successors and assigns from and against any and all losses, costs, expenses (including, without limitation, actual attorneys' fees, at all levels including appeals), damages, liabilities, demands or claims of any kind whatsoever, ("Claims") incurred by a third party directly arising out of, related to, or in connection with (i) any act taken by Meridian (or its substitute or substitutes) pursuant to this Limited Power of Attorney, which act results in a Claim solely by virtue of the unlawful use of this Limited Power of Attorney (and not as a result of a Claim related to the underlying instrument with respect to which this Limited Power of Attorney has been used), or (ii) any use or misuse of this Limited Power of Attorney in any manner or by any person not expressly authorized hereby. Nationstar shall indemnify, defend and hold harmless Meridian and its affiliates, successors and assigns from and against any and all Claims incurred by a third party directly arising out of, related to, or in connection with (i) Meridian's lawful use of this Limited Power of Attorney; or (ii) any act or omission of Nationstar that constitutes gross negligence, willful misconduct or fraud.
