- Note Modification. The terms and provisions of the interim construction financing stated in the Fixed Rate Note in Paragraphs 2 and 3, are amended and modified as follows:
 - Interest. Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of Lender. Interest will be charged on the unpaid principal until the full amount of the Unpaid Principal Balance has been paid. Borrower must pay interest at a yearly rate of 6.125%. This interest rate shall apply both before and after any default described in the Fixed Rate Note.
 - (b) Payments, Borrower promises to make monthly payments in the amount of U.S. \$3,722.66.
