- Covenants to Run with Land. The covenants, conditions, restrictions, and easements contained in the Declaration, as amended by this Supplement, shall run with and bind the Premises.

Continuation. As expressly hereby amended, the Declaration shall continue in full force and effect in accordance with its terms.
