LAST WILL AND TESTAMENT OF BENNYE HUNTLEY

 BENNYE HUNTLEY, a resident of Lake County, Indiana, declare this to be my last will and testament, hereby revoking all prior wills and codicils.

Article 1

I hereby direct that the expenses of my last illness, funeral and burial, costs of administration, and all taxes, including interest and penalties thereon, payable by reason of my death, shall be paid from and charged generally against the principal of my residuary estate, without apportionment or pro-ration.

Article 2

At the time of my death, I direct my heirs to have my funeral at New Mount Moriah church and to bury my remains at the funeral plot that I have already purchased.

Article 3

A. I hereby give my home to my son Arthur Lee Huntley. All of the furniture and assets in my home at the time of my death I also leave to my son Arthur Lee Huntley.

ARTICLE 4

I hereby nominate and appoint Ophelia Garmon as personal representative of my estate.

If Ophelia Garmon is unable or unwilling to so serve, I then nominate and appoint Diana Borom as the alternate personal representative. To the extent permitted by law, my personal representative shall not be required to give any bond to secure the faithful performance of the

personal representative's duties; nor to obtain the order or approval of any court in the exercise of any power or discretion, although the personal representative may obtain such order or approval as the personal representative deems advisable; nor to make any accounting of the personal representative's activities to any court, although the personal representative is not precluded from seeking judicial approval of accountings. I specifically authorize the administration of my estate without court supervision.
