KNOW ALL MEN BY THESE PRESENTS:

That we, R. Carlson & Sons, Inc.
as Principal, and Selective Insurance Company of America, a corporation of the State of New Jersey, as Surety, are held and firmly bound unto the Lake County & All Cities & Towns Thereof as Obligees in the penal sum of Ten Thousand Dollars & Zero Cents and City of Gary (Not valid for more than (\$25,000):

lawful money of the United States, to be paid to the said Obligees, for which payment well and truly to be made we bind ourselves and our legal representative, jointly and severally.

The condition of this obligation is such that whereas Principal is desirous of obtaining a license or permit to carry on business as a General Contractor & Excavation

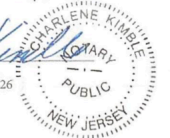
