FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR STREAMSIDE ESTATES

THIS FIRST AMENDMENT is entered into this <u>1</u>th day of February, 2024, by SOUTH LAKE COUNTY DEVELOPMENT LLC (hereinafter referred to as "Declarant").

WHEREAS. Declarant executed that certain Declaration of Covenants, Conditions and Restrictions for Streamside Estates recorded in the Office of the Recorder of Lake County, Indiana on November 14, 2023, as Document no. 2023 050355 (the "Declaration");

WHEREAS, Declarant reserved the right and option to amend the Declaration pursuant to Article XIII, Section 13.02;

WHEREAS, Declarant now desires and intends hereby to so amend the Declaration; and

NOW THEREFORE, Declarant does hereby amend the Declaration as follows:

- 1. Except as amended herein, the Declaration is in full force and effect.
- Article IX, Section 9.10, (a), (b) and (c) is hereby deleted in its entirety and replaced with the following:
 - (a) At the closing of a Dwelling, the purchaser shall assume purchaser's prorata share of the assessment attributable to the Dwelling for the assessment period during which the closing occurs.
 - (b) At the closing of the Dwelling, the purchaser shall pay a reserve capital fee in an amount equal to one (1) time the quarterly assessment fee for the Association. Said capitalization fee is non-refundable and is not a pre-payment of monthly assessments.
 - (c) At the closing of a Dwelling, the purchaser shall pay a working capital fee in an amount equal to one (1) time the quarterly assessment fee for the Association. Said capitalization fee is non-refundable and is not a pre-payment of monthly assessments.
- Unless otherwise provided, all capitalized terms herein will have the same meaning as given in the Declaration.
