AN ORDINANCE VACATING A 330-FOOT PORTION OF CLINTON STREET LYING BETWEEN THE EAST RIGHT-OF-WAY LINE OF HOHMAN AVENUE AND THE WEST RIGHT-OF-WAY LINE OF VACATED LYMAN AVENUE, WHICH PORTION OF CLINTON STREET IS LOCATED IN THE CITY OF HAMMOND, LAKE COUNTY, INDIANA.

WHEREAS, United States of America is the fee simple owner of the following described real estate, to wit:

WHEREAS, a 330-foot portion of Clinton Street lies between lots 29 through 35 in Block 1 in Towle and Young's Addition to the Town (now City) of Hammond and lots 10 through 17 in Block 2 in Towle and Young's Addition to the Town (now City) of Hammond, which 330-foot portion is more particularly described in attached Exhibit B; and

WHEREAS, the United States of America, acting by and through the Administrator of General Services, has filed a Petition for Vacation of a Street with the Common Council of the City of Hammond, Lake County, Indiana, requesting vacation of a 330-foot portion of Clinton Street; and

WHEREAS, the Common Council of the City of Hammond, Lake County, Indiana upon investigation and Public Hearing in accordance with applicable law, finds and determines that the proposed vacation will not hinder the growth or orderly development

of the City of Hammond, Lake County, Indiana, or the neighborhood in which it is located or to which it is contiguous; and

WHEREAS, the vacation will not make access to the lands of any persons by means of public way difficult to inconvenient; and

WHEREAS, the vacation would not hinder the public's access to a church, school, or other public building or place; and

WHEREAS, the vacation will not hinder the use of a public way by the neighborhood in which it is located or to which it is contiguous.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND, LAKE COUNTY, INDIANA, THAT it is desired and deemed necessary to vacate a 330-foot portion of Clinton Street located between the east right-of-way line of Hohman Avenue and the west right-of-way line of vacated Lyman Avenue, which portion of Clinton Street in the City of Hammond, and is more particularly described in attached Exhibit B; and, therefore, the aforementioned 330-foot portion of Clinton Street is hereby vacated, subject to easements, if any, for existing water, sewer, gas, telecommunications, and utilities in place and adjoining lot are extended by operation of law to include the proportionate part of Clinton Street hereby vacated.

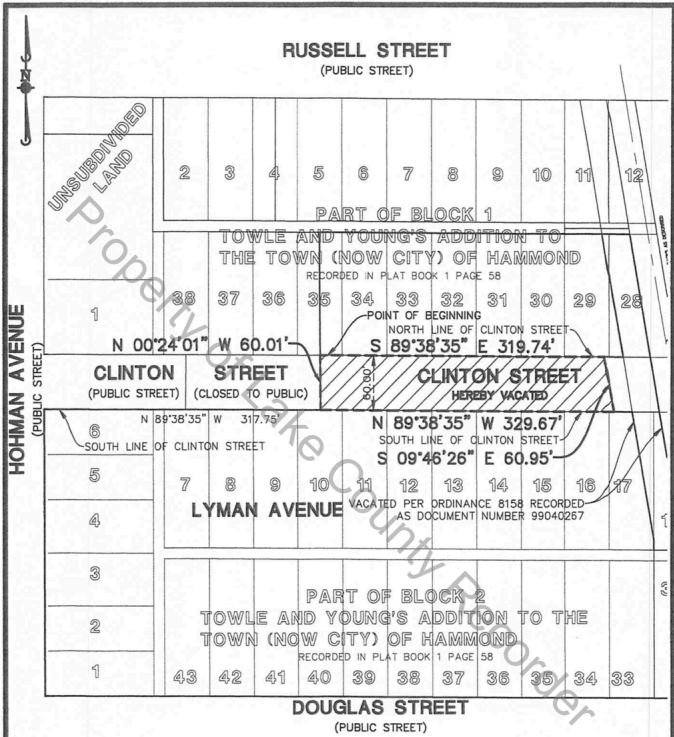

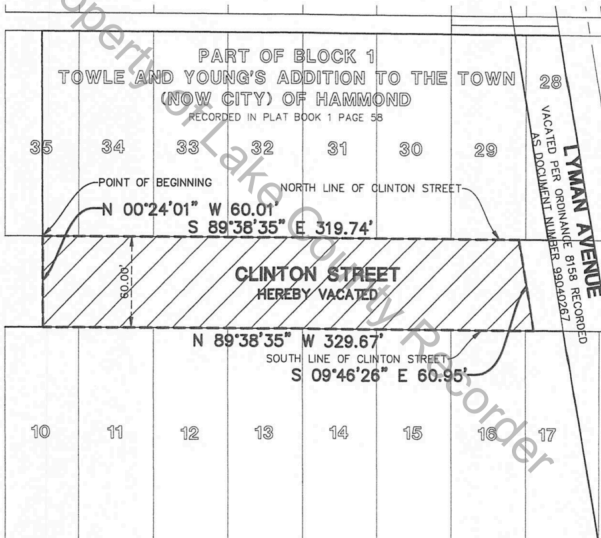

WHEREFORE, the Petitioner, United States of America, acting by and through the Administrator of General Services, respectfully request the Common Council of the City of Hammond, Lake County, Indiana, after due notice and Public Hearing in accordance with the law, to enact an Ordinance pursuant to its authority under Indiana Code § 36-7-3-12, as amended from time to time, vacating the following 330-foot portion of Clinton Street:
