
6. The purposes of this Name Affidavit are:

Further Affiant saith not.

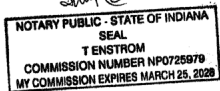
