KNOW ALL MEN BY THESE PRESENTS:

THAT WE, RYAN INCORPORATED CENTRAL, as Principal, and Travelers Casualty and Surety Company of America, a corporation duly incorporated under the laws of the State of Connecticut and authorized to do business in the state of INDIANA, as Surety, are held and firmly bound unto The Board of Commissioners of the County of Lake, State of Indiana (the "Board"), and all cities, towns and municipalities in Lake County, Indiana, as Oblige, in the penal sum of Five Thousand (\$5,000.00) Dollars, for the payment of which we hereby bind ourselves, our heirs, executors and administrators, jointly and severally, firmly by these presents.

PROVIDED, that regardless of the number of years this bond is in force, the Surety shall not be liable hereunder for a larger amount, in the aggregate, than the penal sum listed above.

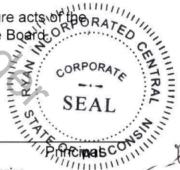

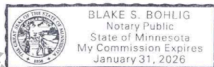
