I am no longer liable and cannot be held liable for: 1) Maritime liens being enforced against me, and 2) Securities being taken out of the estate. Further:

*All Maritime liens being enforced against me, the living soul, I hereby claim invalid, null & void, ab initio, nunc pro tunc. Note that I am the infant without a Social Security Number, which makes me the Agent and Beneficiary of this trust. Being that the IRS works in Admiralty, the IRS according to its own code, can no longer enforce Maritime liens against me, the living man/woman/soul, as I have now claimed. 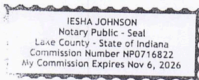
