this obligation shall be null and void, otherwise to remain in full force and effect.

This bond shall become effective on 10/11/2024 and shall remain in force until  
10/11/2025 or until canceled as provided herein.

PROVIDED, that regardless of the number of years this bond is in force, the number of premiums paid or the  
number of claims made, the aggregate liability of the Surety shall not be cumulative from year to year and in  
no event shall exceed the penal sum stated above.

PROVIDED FURTHER, that the Surety may cancel this bond at any time by filing with the Oblige thirty (30)  
days written notice of its intent to be relieved of any future liability. The Surety shall not be discharged from  
any liability already accrued under this bond, or which shall accrue hereunder before the expiration of the  
thirty (30) day period.

Any such appointment may be revoked, for cause, or without cause, by any of said officers, at any time."

In connection with obligations in favor of the Florida Department of Transportation only, it is agreed that the power and authority hereby given to the Attorney-in-Fact includes any and all consents for the release of retained percentages and/or final estimates on engineering and construction contracts required by the State of Florida Department of Transportation. It is fully understood that consenting to the State of Florida Department of Transportation making payment of the final estimate to the Contractor and/or its assignee, shall not relieve this surety company of any of its obligations under its bond.

In connection with obligations in favor of the Kentucky Department of Highways only, it is agreed that the power and authority hereby given to the Attorney-in-Fact cannot be modified or revoked unless prior written personal notice of such intent has been given to the Commissioner - Department of Highways of the Commonwealth of Kentucky at least thirty (30) days prior to the modification or revocation.


