7. That pursuant to Indiana Code 29-1-7-23, the above-referenced property should be transferred to Rogelio Camarena and Jackqueline Contreras.


8. That Affiant, Jackqueline Contreras, is the adult daughter of Maria Gloria Alvarez.

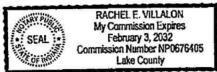


